

Real-Time Analytics provides on-demand workable Key Performance Indicators (KPIs), insights, and alerts to help you grow revenue, improve profitability, and increase your base of loyal customers. Logging in at the account level, allows for filtering on individual Merchant IDs, (MIDs) and logging in at the MID level, enables a deeper look into those transactions.

Overview

Section 1 Horizontal Filtering Toolbar and Export Function

If you are logged in to the SSO (_acct) level, six toolbar filters are displayed, including one for merchant IDs within that group. If you are logging in to a specific MID, the merchant ID filter will not be available because only data from the specific MID is accessible. The filters are drop-down menus from which you can choose other dimensions if they apply, and from which you can change the results that are displayed.

TIP Use the **Choose a filter** drop-down menu to replace the default **Currency: All** filter with **Reason Code** to better understand your declines.

The last filter defaults to **Currency: All**. You can change category using the **Choose a filter** drop-down menu below the filters. Click **CLEAR** to restore filters to their original states.

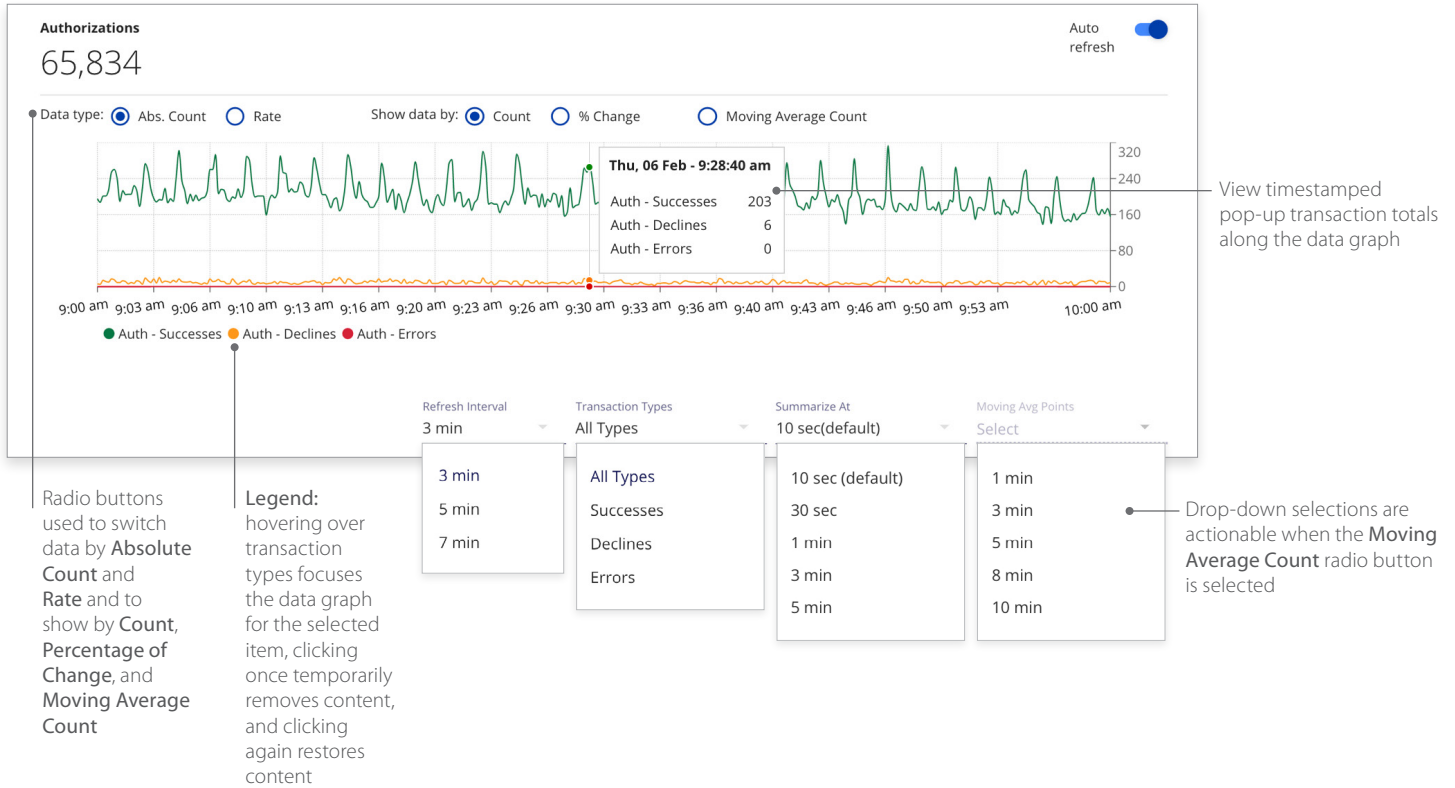

Section 2 Data Graph

You can view the day's authorizations (from midnight), which adjust with the filter selections. Above the graph are radio buttons to display data using other measures. Hovering over any section within the graph displays a pop-up dialog box with totals for **Successes, Declines, and Errors** for the selected time.

Below the graph, drop-down menus for **Refresh Interval, Transaction Types, and Summarize At** or **Moving Avg Points** provide further options to view data. Hovering over any code in the legend brings focus to that area in each bar. Clicking on a legend authorization makes it unavailable and temporarily removes the content from the display. Clicking again on the code restores the content to its original state.

Section 2 Successes and Declines Comparison Table

This section gives a count of the day's authorizations for successes and declines (from midnight) for **Count/Count change, Percentage/Percentage change, and Amount/Amount change**. Successes and declines results reflect selections from the horizontal filtering toolbar. Comparisons for both show the day's amount and rate of change and the filtering toolbar selections—in this example, *Last hour*.

Section 3 Dimension Comparison Table

This table features each transaction type and comparison metrics for **Today** with other time dimensions based on the selected filters at the top of the page. Similar to the *Success and Declines Comparison Table*, values in this table are associated with each transaction type. The complete table varies relative to selections made within the horizontal filtering toolbar. Selecting the arrows next to each header displays the data in alphabetical order from A to Z or Z to A. Filter fields below the header allow for searching within the category. The header area scrolls horizontally to reveal more dimensions.
